Shelly Armstrong and Mary Kay MacIver shared information on the draft Ferris State Social Media policy. The draft Social Media Policy also outlines proper precautions regarding important security of usernames and passwords, as well as the proper disclosure for personal comments and established privacy policies (such as HIPPA or FERPA).

Steve Durst presented justification for two tenure-track faculty position in Pharmacy Practice (F21510 and F21540). After discussion concluded, the vote was unanimous for Pharmacy to begin the HAF process.

Fritz Erickson discussed the faculty equity process and Dan Burcham and Linda Telfer were present to listen to this discussion.

Fritz Erickson discussed overloads and release time for various situations. There will be a continuation of this topic at future meetings of the Deans Council.

Don Flickinger gave an update on the recent FNTFO negotiations and announced that a tentative agreement had been made.

Fritz Erickson discussed the College of Arts and Sciences' dean search.

Steve Durst began a discussion of the need for a broad description of faculty positions with the intent to assist colleges when they go through the search process for new and replacement faculty members. Michelle Johnston, Andy Karafa and Steve Durst will review the processes needed to create a generic faculty position description.

Fritz Erickson listened to feedback regarding the Division of Student Affairs' recent Recruiter Transition Proposal that was reviewed by Deans' Council members. Vice President Dan Burcham plans to attend future Deans' Council meetings to further discuss this topic.
